HELOA Group Vice Chair (Partnerships) Role Description

The Group Vice Chair (Partnerships) may be a Primary Contact or HELOA member and will be elected according to procedures set out in the constitution. Each Vice Chair shall normally serve for a two yearperiod of office with an option to stay in post for a third year if agreed by the Group Chair and regional committee.

This is a high profile role within the Association, working closely with and supporting the Group Chairand UK Vice Chair (Partnerships) to develop partnerships with a range of Associations, Organisations, Statutory Bodies and Government. This role requires the individual to build upon the work undertaken at UK level and develop links and partnerships at a regional level which benefit members and support effective information, advice and guidance for those making their Higher Education choices. It will also provide the opportunity to develop many of the skills valued more widely in the higher education sectorand be an excellent platform to progress onto further roles within the Association at Executive level.

Below highlights the core responsibilities of a Group Vice Chair (Partnership) however the UK Executive encourages you to add to these with regards to individual Group aims and objectives in consultation with Group Chairs.

Core responsibilities

- To take responsibility and provide leadership and vision as to the development of partnerships ata regional level linking regularly with UK Vice Chair (Partnerships) to feed into HELOA UK Strategic Plan;
- 2) To work with and support the Group Chair and Vice Chair (Training) where applicable to arrange speakers for group meetings and to produce an annual document outlining the groups objectives for partnership developments for the forthcoming year in line with HELOA UK Strategic Plan;
- To prepare a one page annual report on Partnership development for the group to be integratedinto the Group annual report for AGM;
- 4) To assist the group in developing its profile within the region;
- 5) To chair group meetings in the absence of the Group Chair disseminating relevant news to members from UKC and play an active role in the management and development of the Group;
- 6) To attend UK Committee meetings in the absence of the Group Chair, representing the views and activity of the group;
- 7) To act as a spokesperson/representative of HELOA.
