

## Charity Trustees: What you need to know, what you need to do

We are the <u>Scottish Charity Regulator (OSCR)</u>. We regulate every charity registered in Scotland.

Now that you are a charity trustee, you have responsibilities under the law that you need to know about and duties that you have to fulfil. Being a charity gives your organisation a privileged place in society and carries legal responsibilities. This leaflet gives an outline of your responsibilities as a charity trustee. Much more information and guidance for charities is on our <u>website</u>, including our detailed <u>guidance and good</u> <u>practice for charity trustees</u> and <u>good governance</u>.

## What you need to know

- **1.** Always do what is best for your charity: as a charity trustee you have a legal responsibility to put the interests of your charity above your own interests.
- 2. Know your charitable purpose(s): everything you do should be directed at achieving only the purposes set out in your <u>governing document</u>.
- **3. Understand your charity's finances:** all the charity trustees are responsible for the charity's finances and must have access to the financial records.
- **4.** Act with care and diligence: you have to protect your charity including its beneficiaries, assets and reputation.
- 5. Have a copy of your governing document: know what it says, understand what it means, and what you have to do.
- 6. Declare and manage conflicts of interest: All charity trustees have a collective responsibility to manage conflicts of interest and to act in the charity's interests.
- 7. Understand your charity's legal responsibilities: make sure your charity is meeting its legal duties under charity law and other relevant laws.


8. Work together for the good of the charity: all the charity trustees are collectively responsible for making sure that the charity is run responsibly and lawfully.

## What you need to do

- 1. You must send us your <u>accounts, Trustees' Annual Report, Independent</u> <u>Examination report</u>, and <u>OSCR Online annual return</u> every year.
- 2. Check that your charity's details on the <u>Scottish Charity Register</u> are correct you can update them using <u>OSCR online</u>.
- 3. Tell us about any change to the <u>Principal Contact</u> details for the charity. It's a legal requirement for you to make sure these details are up to date.
- 4. If you want to <u>make certain changes to your charity</u> you **must get our consent** first.
- 5. Make sure your charity <u>publicises that it is a charity.</u>
- 6. Look at the guidance available on our <u>website</u>. As Regulator we can't you give you detailed advice on your individual charity, but we do have general guidance on the requirements of Scottish charity law. There are <u>other organisations that</u> <u>should be able to help</u> with specific queries about your charity.
- 7. See if your charity might qualify for <u>Tax relief</u> from HMRC or <u>Water charge</u> <u>exemptions</u> from the Scottish Government's scheme.
